# **REGULATIONS FOR PRECISION SHOOTING**

# **1. SECTION I**

# 1.1 DEFINITIONS

### 1.1.1 Underwater Target Shooting

Underwater Target Shooting is a sports discipline practiced in a swimming pool by an athlete equipped in compliance with these regulations, and whose autonomy underwater depends exclusively on his capacity to hold his breath.

# 1.1.2 Age In order to take part in Underwater Target Shooting competitions competitors must be at least 16 years of age.

### 1.1.3 Precision shooting

- 1.1.3.1 Precision shooting is an individual specialty.
- 1.1.3.2 Precision shooting consists in firing 10 shots on a fixed target in only one round with a time of 10 minutes.
- 1.1.3.3 The sheet consists of five (5) targets and the athlete must fire two (2) shots on each target
- 1.1.3.4 Between each shot the athlete must to recover his spear fixed in the plat, to go up again to the surface and to return near the shooting line. The competitor prepare and load the gun, which may take place either on the surface or on the bottom of the pool but always pointing in the direction of the target.

Each shot is made at a distance of 3 meters from the target support called the firing line. .Before firing, the point of the arrow must not enter the firing zone .After firing, the competitor and his crossbow go in apnea to the target support in order to recover the arrow fixed in the breastplate .Then he returns in its preparation zone for the next shot. he must respect the rules of safety and always arm in the direction of the firing point on the surface or in apnea

- 1.1.3.5 4 The gun must be supported by one arm only and held by one hand only without other supports on the arm or any other part of the body.
- 1.1.3.65 During the shot the other arm may be used to provide stability to body or when applicable to the suction cap positioned there with the fee hand
- 1.1.3.6 The precision shot provide two distinct modes of competition:

a) <u>Precision Traditional;</u> b) <u>Precision Advanced;</u> Each with separate classifications

### 1.1.4 Use of masculine pronoun

In these regulations, all grammatical parts of the text referring to persons use the masculine gender. This is obviously an expedient to simplify comprehension, and it is expressly stated to the reader that references in these regulations apply independently from the gender of the person, whatever his or her role, who participates in a Precision Shooting event.

- **1.1.5 Violation of the regulations** The violation of the provisions set forth in these regulations shall cause the application of penalties to the competitor.
- 1.1.6 CMAS licence

# Each competitor must be in possession of the CMAS sports licence.

# 2. SECTION II

2.1 GENERAL TECHNICAL ASPECTS

# 2.1.1 Athlete categories, materials and equipment

## 2.1.1.1 Categories

2.1.1.1.1 Official competitions of precision shooting have the men's and women's categories.

# 2.1.1.2 Authorized materials

2.1.1.2.1 During the competition the use of the following equipment is allowed:

fins, mask, snorkel, wetsuit, ballast, gloves, suction cap, replacement gun, replacement spear with line, positioning items.

- 2.1.1.2.2 No other equipment is allowed.
- 2.1.1.2.3 The replacement gun shall be used only if the first gun is broken.
- 2.1.1.2.4 The use of torches is prohibited.
- 2.1.1.2.5 The use of reel is forbidden.

### 2.1.1.3 Characteristics of the gun

- 2.1.1.3.1 **Only** rubber-powered spearguns can be used in the competitions, with spears having a length up to **150 cm**.
- 2.1.1.3.2 No wooden rubber-powered guns may be used even if they are mass-produced.
- 2.1.1.3.3 The diameter of the spear must not exceed **8 mm**.
- 2.1.1.3.4 The tip of spear must be sufficiently pointed to penetrate easily into plate. The tip must be conform to the following measures: Minimum 11 mm the distance between the base of the cone at its end Maximum 30° angle
- 2.1.1.3.5 The spear is obligatorily connected to the speargun be an elastic line, without of

ballast or floatation elements, sufficiently solid to resist an off targhet shooting It can add a rubber or elastic shock absorber with a maximum length of 20cm

2.1.1.3.6 Guns with elastic lines and the use of one pulley only is allowed.

- 2.1.1.3.76The elastic line must measure not less than **1.00** mm and must be secured to the spear and the gun in such a way as to prevent easy breakage.
- 2.1.1.3.8 7 The regularity of the weapon is checked in advance and may be verified, upon request by the Competition Judge, with a shot in the water.
- 2.1.1.3.9 8 T h e gun must be loaded only with the strength of the arms.
- 2.1.1.3.109 The gun must be mass-produced for underwater fishing, verifiable and with a recognized brand, not altered or customized. The producer must be officially registered.

The gun may be either assembled or self-contained. With regard to assembled guns, they may have different features compared to models listed in catalogues, provided that they result from industrial mass production of the same brand.

The gun being used, whether power band or pneumatic, shall at any rate not exceed the following standard dimensions:

• m a x i m u m all-out length (from the gun's rearmost point near the grip to its foremost point near the head), including any accessories: **1500 mm** for the **Precision Traditional** and **1000 mm** for the **Precision Advanced** 

- m a x i m u m width, including any accessories: 80 mm;
- maximum height, including any accessories and excluding the grip (handle, trigger and release mechanism): 50 mm
- Overall weight, excluding spear: 1000 g
- 2.1.1.3.12 10 All sighting devices, whether mass-produce or custom made, such as bow or rifle laser sights, fixed or adjustable, all optical sighting devices altering the visibility and all modifications to the structure of the gun that may be used as a sighting device are prohibited. Fins, balances, counterweights, spear guides with fins, any support between gun and body or gun and arm as well as custom made anatomical grips are prohibited.
- 2.1.1.3.1311 The spear, line, tip and elastics can be replaced.

## 2.1.2 Competition Zone

- 2.1.2.1 The competitions shall take place in a pool with the following characteristics:
- 2.1.2.1.1 Water temperature between 23 C+/5C.;
- 2.1.2.1.2 Minimum size of 10.00 x 25.00 metres with minimum depth of 1.80 metres and a maximum of 5.00 metres.
- 2.1.2.1.3 Eventual exceptions must be authorized by CMAS.

## 2.1.3 Organization of the Competition Zone

- 2.1.3.1 The Competition Zone is divided as follows:
- 2.1.3.1.1 <u>Safety zone</u>:

The area of water behind the targets, where stopping or transit is absolutely prohibited.

2.1.3.1.2 <u>Competition zone</u>:

The area of water reserved for competitors for undertaking the trial.

2.1.3.1.3 Departure zone:

The area of water located before the competition zone and used by the athletes awaiting their turn in the competition.

2.1.3.1.4 Call zone:

The area of water between the departure zone and the warm-up zone.

#### 2.1.3.1.5 <u>Warm-up zone</u>:

The area of water used by the athletes for the pre – competition warm-up.

### 2.1.4 Layout of the Competition Zone.

- A Target line
- **B** Shooting line
- C Departure line
- **D** Border line of call zone
- E Warm-up zone



- 2.1.5.1 The following actions are prohibited:
- 2.1.5.1.1 Loading gun in any part of the pool except when the trial is performed in the Competition zone;

2.1.5.1.2 Entering space A/B;

2.1.5.1.2 Entering space C/D during the warm-up phase.

## 2.1.6 Targets

- 2.1.6.1 The target sheet for precision shooting has a rectangular shape and measures cm. 33 x 35 and with white background, and is placed at a height of 80 cm from the bottom of the pool; this measurement will refers to the centre of the target, which corresponds to the central point of the 1° ring of the central target.
- 2.1.6.2 The sheet includes five (5) identical targets, each consisting of six (6) concentric circles, divided by a white line between two black circles, and a black line in the other cases, containing the following values:

## 2.1.7 Score evaluation

- 2.1.7.1 The evaluation of the score to assign to the targets will take place at the end of the trial in a specially reserved zone.
- 2.1.7.2 One of the possible evaluation scoring systems could be the following:

the evaluation of every single shot will take place by the use of a special graduated scorecard. The score will be determined by positioning a needle with a diameter of 6.5 mm in the impact hole of every single target and matching the target with the circular references. The middle of this needle will determine the score to assign to each shot, which will be read directly on the graduated scorecard.

- 2.1.7.3 If the reference on the graduated scale is in an intermediate position between two (2) values, the higher value will be assigned.
- 2.1.7.4 If the middle of the shot is off the graduated scale, the score to assign will be zero (0).If the point of impact of the spear is not clearly visible on the sheet, thereby preventing the plug from being inserted and the score from being assessed, then the score shall be assessed directly by the Competition Judge (or Chief Judge).
- 2.1.7.5 At the end of the evaluation, the sheet with the targets will be made available to the captain of the team or, in his absence, the competitor, who after viewing it in the presence of the Competition Judge, will endorse the result.
- 2.1.7.6 In case of a challenge, the captain or athlete are entitled to submit a complaint in the ways and terms set forth in these regulations.
- 2.1.7.7 Other evaluation scoring systems could be foreseen by the special rules of the single sports events scheduled in the CMAS Calendar, provided they must have been previously approved by the Underwater Target Shooting CMAS Commission.

### 2.1.8 Violations and penalties

- 2.1.8.1 An athlete who, during the competition, commits a violation of the provisions contained in these regulations shall be subject to penalties according to the seriousness of the violation committed, as stated below:
- 2.1.8.1.1 Crosses the shooting line with the tip of the spear at the time of shooting.

## Penalty: one hundred (100) points.

2.1.8.1.2 Goes back behind the departure line without resurfacing, once the ten (10) shots are completed.

Penalty: one hundred (100) points.

2.1.8.1.3 Loads or tries the competition gun in moments other than the trials or his own competition.

Penalty: relegation to last place with zero points (0).

2.1.8.1.4 Leaves the loaded gun on the bottom.

Penalty: relegation to last place with zero points (0).

2.1.8.1.5 Ties a knot to connect two parts of line, if the line breaks during the competition.

Penalty: relegation to last place with zero points (0).

- 2.1.8.1.6 Enters the competition before the other competitors have finished the trial. <u>Penalty: relegation to last place with zero points (0).</u>
- 2.1.8.1.7 The judge declares that a gun is irregular.Penalty: relegation to last place with zero points (0).
- 2.1.8.1.8 Exceeds the time of ten (10) minutes for the execution of a round.Penalty : Worst shot with the score above zero will be refused
- 2.1.8.1.9 **Three (3)** shots or more on the same target.

Penalty: annulment of excess shots on the same target with a higher score.

2.1.8.1.10 O v e r ten (10) shots on the same sheet.

Penalty: relegation to last place with zero points (0).

2.1.8.1.11 F i r e s more than one (1) shot during the same apnea.

Penalty: relegation to last place with zero points (0).

2.1.8.1.12 L o a d i n g gun on the surface or in apnea without pointing the tip towards the target.

Penalty: relegation to last place with zero points (0).

2.1.8.1.13 Unsporting behavior.

Penalty: relegation to last place with zero points (0).

2.1.8.1.14 R e t u r n i n g to the surface with the gun loaded.

Penalty: relegation to last place with zero points (0).

2.1.8.1.15 G o i n g over the shooting line with any part of the body.

Penalty: relegation to last place with zero points (0).

2.1.8.1.15 The competitor, after completing the trial, may collect his equipment only after all the competitors of that round have completed the trial and only after being authorized, otherwise:

Penalty: relegation to last place with zero points (0).

# 2.2 COMPETITION OFFICIALS AND STAFF WITH ASSISTANCE DUTIES

## 2.2.1 General provisions

- 2.2.1.1 The persons who act as competition officials and assistants may not make decisions autonomously but must consult each time with the Competition Judge who is the only person authorized to express the definitive decision.
- 2.2.1.2 The competition officials and assistants are responsible for managing the competition.
- 2.2.1.3 The staff of the competition officials and the assistance personnel are:
  - Competition Judge;
  - Director of Competition;
  - Shooting line judge;
  - J u d g e checking shots and awarding score;
  - Starter;
  - Timers;
  - Competition secretary;
  - Competition physician;
  - Assistants.
- 2.2.1.4 The staff consisting of the Director of Competition, competition officials and the assistance personnel, except for the Competition Judge, are appointed by the organization.

### 2.2.2 Competition Judge

- 2.2.2.1 In the World and Continental Championships the Competition Judge is designated by CMAS.
- 2.2.2.2 The Competition Judge exercises control and authority on the staff mentioned in point 2.2.1.3
- 2.2.2.3 The Competition Judge has the following tasks:
- 2.2.2.3.1 To inspect the facilities where the competition is to take place;
- 2.2.2.3.2 To check the validity of the participants' documents;
- 2.2.2.3.3 To check and approve the registration forms and to establish the order of performance of the trials;
- 2.2.2.3.4 To approve and endorse the ranking before the results are made public.
- 2.2.2.4 The Competition Judge must guarantee compliance with the instructions and solve any problems regarding the organization of the competitions in cases where the regulations do not provide specific indications.
- 2.2.2.5 He must guarantee, for the correct organization of the competition that all the competition officials and assistants necessary for the correct undertaking of the competition are present in the roles and position assigned to them. He may appoint replacements for competition officials who are absent, unable to attend

or who are unable to undertake their tasks. Should he deem it necessary, he may appoint additional competition officials.

- 2.2.2.6 He authorizes the Starter Judge, in charge of starting, to give the starting signal, after ascertaining that all the persons forming the staff are correctly positioned and ready to perform their tasks.
- 2.2.2.7 He may annul the start of the trial and order a new starting procedure.
- 2.2.2.8 The Competition Judge, in agreement with the Director of Competition, may suspend or annul the competition in cases of force majeure; this faculty may be exercised, by way of example only, for bad weather conditions (if the event takes place in an outdoor pool), or when the facility where the competition takes place no longer appears to comply with the standards required by regulations.
- 2.2.2.9 The Competition Judge apply a penalty on any athlete for any violation or irregularity that he observes personally or which has been referred to him by the other competition officials.

### 2.2.3 Director of Competition

2.2.3.1 The Director of Competition supervises and coordinates all the organizational stages of the competition, with the collaboration, insofar as coming within his jurisdiction, of the competition officials (except the Competition Judge) and of the assistants.

#### 2.2.4 Shooting line judge

- 2.2.4.1 This judge must be positioned on the shooting line, represented by a black line on the bottom and a floating line on the surface.
- 2.2.4.2 The judge checks the shooting line and informs the Competition Judge on:
- 2.2.4.2.1 The crossing of the shooting line with the tip of the spear or with any part of the body;
- 2.2.4.2.2 The number of shots, violations of the regulations and unsporting behaviour.

### 2.2.5 Judge for monitoring shots and assigning scores

- 2.2.5.1 The Judge in charge of the proper conservation of the targets until the end of the competition; views the shots and assigns the score by the use of the graduated scorecard.
- 2.2.5.2 The checking must be conducted out of the water and only the single captains or, in their absence, the athletes may be present for the checking, endorsing the result.

#### 2.2.6 Starter

2.2.6.1 The starter has the task of giving the starting signal when the competitors, judges, and timers are at their places.

#### 2.2.7 Timers

- 2.2.7.1 Each trial is timed without interruptions from the start to the end with an accuracy of one tenth of a second.
- 2.2.7.2 For each trial, the time starts when the starter gives the starting signal.
- 2.2.7.3 The time is stopped when the competitor raises his hand out of the water, beyond the departure line.
- 2.2.7.4 The time is recorded by the timers in minutes, seconds and tenths of a second.

### 2.2.8 Competition Secretary

- 2.2.8.1 The Competition Secretary has the task of checking the accuracy of the notes written regarding the results and on the positions communicated by the Competition Judge.
- 2.2.8.2 Appoints his own assistants and coordinates their work.
- 2.2.8.3 Prepares all the secretariat material and documents necessary for the competition.
- 2.2.8.4 Verifies the results, reports new records by inserting them in the record officials' reports. Inserts this documentation in the competition report, making it available to the Competition Judge.
- 2.2.8.5 Conveys the results on the three top ranking athletes and on the composition of eventual play-offs.
- 2.2.8.6 The official results and ranking of the athletes must not be communicated by the secretary for their subsequent distribution without first being authorized by the Competition Judge.
- 2.2.8.7 Prepares the final competition report.
- 2.2.8.8 When there is a press office, the Competition Secretary may, with the permission of the Director of Competition, communicate information on the competition to the media.

### 2.2.9 Competition Physician

2.2.9.1 The Competition Physician must guarantee first aid measures to persons who have accidents, providing them with the necessary help from the moment when the accident occurs to recovery of healthy conditions at local healthcare facilities.

## 2.2.10 Other assistants

2.2.10.1 The Organizing Committee appoints the other assistants deemed necessary for the competition; these persons are under the authority of the Director of Competition who, together with the Competition Judge, determines the various tasks to be assigned to each of them.

### 2.2.11 Preliminary Meeting

- 2.2.11.1 The day before the competition, a meeting must be held between:
  - the Director of Competition;
  - the Competition Judge;
  - the Captains;
  - the organization Physician.
- 2.2.11.2 The purpose of the meeting is to define:
  - Technical issues;
  - Times and transportation;
  - Instructions on the opening and closing ceremonies;
  - Times and swimming pools reserved to each team;
  - Safety measures.
- 2.2.11.3 <u>During the meeting, these rules may not be modified for any reason</u> <u>whatsoever.</u>

### 2.2.12 Jury

- 2.2.12.1 The Jury shall consist of five (5) members and two (2) substitutes:
  - the Competition Judge acting as President;
  - one (1) representative appointed by the organizing Federation;
  - three (3) representatives appointed by and from among the Captains;
  - two (2) substitutes appointed by and from among the Captains.
- 2.2.12.2 The Jury has the task of examining the complaints received and shall make a decision within one hour from presentation.
- 2.2.12.3 A complaint can be accepted only if submitted by the team captain or a competitor in the absence of the captain.
- 2.2.12.4 The complaint must be submitted in writing, in either French, English or Spanish, within the non-renewable term of sixty (60) minutes from the posting of the ranking results.
- 2.2.12.5 The presentation of the complaint must be accompanied by a caution deposit of 100.00 (one hundred) Euro, which will be returned only if the complaint is accepted by the Jury.
- 2.2.12.6 The complaint must be made by **Form A** (attached) and presented solely and exclusively to the Competition Judge.

- 2.2.12.7 The decisions are taken by majority vote, in the presence of at least four members of the Jury.
- 2.2.12.8 In case of a tie, the President's vote will be decisive.
- 2.2.12.9 The decisions of the Jury are not subject to appeal unless new elements not considered at the time the complaint is examined should arise.
- 2.2.12.10 The decision must be communicated immediately to the applicant at the end of the meeting.
- 2.2.12.11 The Competition Judge shall communicate this decision in writing, using **Form B** (attached).

# 3. SECTION III

# 3.1 DRAWS

**3.1.1** The order of departure of the athletes will be decided on the basis of a draw performed by the Competition Judge. This draw must be made in the presence of the Competition officials in charge and the captains of each team present.

# 3.2 CONDUCTING OF THE COMPETITION

- **3.2.1** The competitor is requested by the organization to prepare his competition position in a maximum time of two (2) minutes, and then must take position behind the departure line and await the starting signal of the trial, which will be given within one (1) minute.
- **3.2.2** The trial is undertaken with the following phases:
- 3.2.2.1 The athlete takes position behind the departure line and awaits the signal.
- 3.2.2.2 After the starting signal of the competition, the athlete swims on the surface to the vicinity of the shooting line where he can choose whether to load gun in apnea or on the surface, then fires the shot, holding the gun with one arm and one hand only.
- 3.2.2.3 After firing, the athlete must to recover his spear fixed in the plat, to go up again to the surface and to return near the shooting line, and after reloading the gun, repeats the sequence until firing the tenth (10°) shot.

After the shot the competitor and his speargun go apnea to the target support in order to recover the arrow fixed in the plate. Then he returns in surface to his preparation zone for the next shot and repeats the sequence until the tenth (10°) shooting in accordance with the rules of safety and always arm in the direction of the firing point on the surface or in apnea

3.2.2.4 The round ends when the athlete, having fired all the shots, surfaces on the shooting line and swims back with the gun beyond the departure line where he raises his hand to signal the end of the trial.

3.2.2.5 The winner is the athlete who has obtained the highest score, after subtracting eventual penalties.

3.2.2.6 In case of a tie score, only for the top three (3) places of the ranking, there will be one or more playoff rounds until the winner and the other two places are determined.

# 3.3 PARTICULAR INCIDENT

- **3.3.1** When the competition takes place provision is made for particular incidents. A particular incident during the conducting the competition is defined as the breaking of the gun or problems with the equipment of the organization or of the competition facilities.
- **3.3.2** In case of breakage of the gun or the line, the athlete may replace the gun with a replacement gun or with a spear complete with line in excellent condition, while positioned behind the departure line, before the start of the competition.
- **3.3.3** During the operation of changing the weapon, the time count is not interrupted.
- **3.3.4** If the replacement gun or the spear are not positioned behind the departure line the athlete will complete the trial and the shots fired up to that time will be evaluated.
- **3.3.5** The replacement gun may be used only if the first gun breaks.
- **3.3.6** The guns replaced are checked by the Competition Judge, and if he does not acknowledge the particular incident, will apply a penalty to the athlete.
- **3.3.7** Competitors during the competition are not allowed to make any type of repairs to the gun or parts of the gun.
- **3.3.8** In case of a particular incident due to problems due to the equipment of the organization or the competition facilities, the following procedures shall be as follows:
- 3.3.8.1 The athlete subject to the interruption must report the incident by raising an arm to interrupt the timing of his performance, after which he has to return behind the departure line, also without his own gun, if the spear remains stuck in the target.
- 3.3.8.2 The recording of the time will be interrupted, while the competition of the other athletes will duly continue.
- 3.3.8.3 Once the trials of all the competitors of the same set are completed with the return behind the departure line, the problem that has caused the particular incident will be solved, and the athlete involved in the incident will be invited to return near the shooting line where, after a countdown of 30 seconds, the starting signal will be given again.

- 3.3.8.4 From that moment the athlete can complete the remaining shots while the time taken is added to the time already counted.
- 3.3.8.5 Once the fifth shot is fired, the athlete will swim on the surface back behind the departure line where he will raise an arm to show that the trial has been completed, interrupting the time.

# **4**.SECTION IV

# 4.1 **RESPONSIBILITY**

- **4.1.1** The entry form sent by the relevant Federation, signed by its President, shall guarantee that all team members are at least 16 years of age, meet the requirements established for practicing underwater activity and are aware of diving safety rules.
- **4.1.2** The organizing Federation must guarantee during the competitions the necessary assistance for the proper conducting of the competition, and must ensure that there is a first aid service by competent healthcare personnel authorized for this purpose.
- **4.1.3** The organizers and their representatives and collaborators, and the competition officials and judges shall have no liability for any damage to the equipment of the participants, or for any accidents occurring to the competitors and other participants after their participation in the sports event.
